The Ongoing Call to Respect Life

This month marks the 50th anniversary of the *Roe v. Wade* decision legalizing abortion throughout the U.S. During the past half-century, tens of millions of babies have been aborted in this country.



While the *Dobbs v. Jackson* case last year held that the Constitution does not confer a right to abortion, which permitted individual states to adopt their own laws, abortion is still legal in most states.

As people who believe in the sanctity of each and every human life, we still have much work to do to save the lives of children in utero, and to support women in need. The <u>Pastoral Plan for Pro-Life Activities</u>, created by the United States Conference of Catholic Bishops, is a very helpful guide that highlights four areas for parishes to pursue to protect unborn babies as well as other vulnerable people:

- **Public Information and Education** to deepen understanding of the sanctity of human life and the humanity of unborn children, the moral evil of intentionally killing innocent human beings—whether at the beginning of life or at its end—and the mission of the Church to witness to and serve all human life.
- **Pastoral Care** for women with problems related to pregnancy; for all who have been involved in abortion; for those who are disabled, sick, and dying, and their families and caregivers; for those who have lost loved ones to violent crime; and for those in prison sentenced to death.
- Public Policy efforts directed to restoring legal protection to the lives of unborn children and those
 vulnerable to pressures to end their lives by assisted suicide, and to providing morally acceptable alternatives to abortion and assisted suicide.
- **Prayer and Worship** directed to participation in the sacramental life of the Church and in programs of communal and individual prayer, that the culture of death that surrounds us today will be replaced by a culture of life and love.

Now is a good time to prayerfully consider how your parish could be more deeply involved in <u>Project Rachel</u>, <u>Walking with Moms in Need</u>, and the advocacy and outreach efforts of our <u>Diocesan Office of Life Issues</u>.

VICTORY FOR WOMEN AND UNBORN BABIES

In 2022, Catholics around the country joined with the US Conference of Catholic Bishops, the Catholic Labor Network and other workers' rights advocates in calling for the passage of the **Pregnant Workers Fairness Act**. Unexpectedly, it was included in the omnibus budget bill that passed in late December!

The Catholic Labor Network explains that the bill "will close a gap in our nation's civil rights law and ensure millions of pregnant workers and working moms can receive reasonable accommodations light duty, additional breaks, transfers, and time off to recover from childbirth, to prevent serious health complications and keep their



jobs." CLN told this newsletter that "Without you New Yorkers leaning on (Sen.) Schumer it's unlikely it would have happened." THANK YOU for being a voice for pro-life workplace policies!
