## POVERTY AWARENESS MONTH

January is Poverty Awareness Month, a good way to start off the new year aiming to increase our knowledge, empathy and advocacy. One shocking fact to learn is this: the child poverty rate in the United States more than doubled from 2021 to 2022. It's the largest year-to-year spike on record. That meant an **additional 5.2 million children lived in poverty**, according to the latest Census update.



What happened? One of the biggest causes is that a 2021 federal program that provided financial assistance to low income families as part of pandemic relief was ended in 2022. Congress had temporarily expanded the <a href="Child Tax Credit">Child Tax Credit</a>, as part of the American Rescue Plan. When it expired in 2022, low income families lost that level of support that had brought them out of poverty for a time.

## Urge Congress to Oppose Harmful Changes to Immigration Law as a Condition for Supplemental Funding

From the Justice for Immigrants campaign:

In recent days, a handful of senators have been negotiating behind closed doors to reach an agreement on potential changes to U.S. immigration law that could be attached to an emergency appropriations bill focused on international aid.

Proposals reportedly being discussed in the context of these negotiations include curtailing due process through rapid expulsions and nationwide expedited removal, mandating harmful and excessive detention, and making it even more difficult to attain asylum through heightened legal standards.

It's already terribly difficult for people fleeing dangerous conditions in their home countries to be win their asylum cases. We should not be slamming the door to our sisters and brothers.

### **Gas Chamber Execution this Month** From Death Penalty Action:

Kenneth Smith is scheduled for <u>execution</u> in Alabama on January 25, 2024 for the 1988 murder of Elizabeth Sennett.

On November 17, 2022, the state of Alabama FAILED in its attempted lethal injection execution of Kenneth Smith, poking him and cutting him for hours before sending him back to his cell alive. This left him severely physically scarred and deeply traumatized. Now they will try again, this time using a never-before-tried experimental form of the gas chamber, forcing him to wear an airtight mask so that they can suffocate him with what they call nitrogen hypoxia.
