Feeding the Hungry Through Our Advocacy

Feeding the world is good but "American Farmers Feed the World" will be destructive. That sounds like a contradiction, but a current proposed federal bill with that title is opposed by Catholic Relief Services and many other organizations, including the ecumenical anti-hunger advocacy group Bread for the World.

A longstanding international humanitarian assistance program called Food for Peace began decades ago to deliver food from the United States to economically poor countries. This can be life saving in situations of famine and war when farmers in those countries can't grow enough food. However, dumping free commodities like rice on a Third World country when there isn't an emergency situation means that the local farmers can't compete with the price. They have to stop growing their own rice because they are losing money. The country becomes more and more dependent on foreign assistance.

Food for Peace has evolved over the years to make it possible for aid organizations like Catholic Relief Services to use funding through the program to train farmers in better agricultural practices. The proposed American Farmers Feed the World bill would radically change the Food for Peace program, taking away the flexibility to address hunger in low income countries in ways that meet local needs and promote self-reliance.

This is one of many issues that is being debated in negotiations about the federal Farm Bill, which funds many anti-hunger programs in the U.S. and around the world. The House and the Senate have finally created their own versions of the Farm Bill, so as the work out the differences now is the time to pressure them to ensure that the final bill leaves fewer people hungry.
