# **Election Day is** Tuesday, November 8 📰



You can only vote ONCE but you have many chances to vote. You can vote during Early Voting, happening now until Sunday November 6 OR you can vote at your neighborhood polling place on Election Day.

New Yorkers will be voting for our Federal Senator, Governor, Lieutenant Governor, NYS Attorney General, NYS Comptroller, NYS Assembly Member, NYS Senator, and local government officials.

We'll also be voting on Proposition the 1, CLEAN WATER, CLEAN AIR, AND GREEN JOBS Environmental Bond Act of 2022. The question on the ballot will read: "To address and combat the impact of climate change and damage to the environment, the "Clean Water, Clean Air, and Green Jobs Environmental Bond Act of 2022" authorizes the sale of state bonds up to four billion two hundred million dollars to fund environmental protection, natural restoration, resiliency, and clean energy projects. Shall the Environmental Bond Act of 2022 be approved?

## We keep on nudging the governor

On Wednesday November 16 please plan to call Governor Hochul and ask her to sign the legislation that would place a two year moratorium on new crypto-currency operations. This is the bill that our Diocesan Public Policy Committee was highlighting last spring. It has passed both houses of the NYS legislature. Now it's up to the Governor to act.

### **The Bigger Better Bottle Bill**

Environmental advocates across the state are pushing for the modernization of New York State's 40-year-old Bottle Deposit Law. This would increase the deposit from a nickel to a dime and would expand the types of containers to include sports drinks, iced teas, juices, wine, and liquor. The current law has greatly boosted recycling rates and reduced litter. Expansion would cut solid waste costs for municipal governments and decrease landfill use.
